Additional Information for Special Tax Filing Situations

Student & Spouse (if married) who are not required to file a federal tax return <u>MUST</u> provide the following for EACH Non-filer:

 A copy of IRS Form W–2 for each source of 2023 employment income received (or an equivalent document such as the Wage and Income Transcript) Wage and Income Transcripts can be obtained at www.irs.gov/individuals/gettranscript;

AND

IRS Verification of 2023 Non-filing Letter dated on or after October 1, 2024.

An IRS Verification of Non-filing Letter can be obtained online using the IRS Get Transcript service. If the individual cannot obtain it online, you must request it by mail. Check box 7 on the IRS Form 4506-T, Request for Transcript of Tax Return, and mail it to the IRS. If appropriate, a similar confirmation from another taxation authority (e.g., a U.S. territory or a foreign government) is also acceptable.

Individuals Who Filed an Amended 2023 IRS Income Tax Return, provide:

- A <u>record of account transcript</u> obtained from the IRS that lists the 2023 tax information for the tax filer(s).
 OR
- 2. A <u>signed</u> copy of the 2023 IRS Form 1040X, "Amended U.S. Individual Income Tax Return," that was filed with the IRS;

AND

3. A signed copy of the 2023 IRS Form 1040 and the applicable schedules that were filed with the IRS.

Individuals required to file a 2023 IRS income tax return and were granted a filing extension by the IRS beyond the automatic six-month extension for tax year 2023, provide:

- 1. A copy of the IRS's approval of an extension beyond the automatic six-month extension for tax year 2023; and
- 2. IRS Verification of 2023 Non-filing Letter dated on or after October 1, 2024; and
- 3. A copy of IRS Form W–2 for each source of 2023 employment income received or an equivalent document; and
- 4. If self-employed, a signed statement certifying the amount of AGI and U.S. income tax paid for tax year 2023.

For an individual who was the victim of IRS tax-related identity theft, provide:

- A 2023 Tax Return DataBase View (TRDBV) transcript obtained from the IRS;

 AND
- 2. A statement signed and dated by the tax filer indicating that he or she was a victim of IRS tax-related identity theft and that the IRS has been made aware of the tax-related identity theft.
